7. The Bidding shall be carried out under SPPRA Rule 46(1) Single Stage – One Envelope Procedure.
8. Duly filled Bidding Documents, along with Bid Security, shall be submitted on or before **July 20, 2023 12:00 Hrs** at the office of the undersigned and will be opened on same day at **12:30 Hrs**.
