ELIGIBILITY CRITERIA/QUALIFICATION:

- Details of Machinery /equipment and Technical Staff.
- Valid PEC Registration Certificate in relevant category for the year 2023.
- National Tax Number Certificate and Annual Return Statement of FBR(Last 3 Years)
- Sindh Revenue Board Registration Certificate.
- Bank Statement/Financial Turn over last Three year.
- Three (03) years experience in the Relevant Field.
- Affidavit that the bidders have not been Black listed by any Government/Semi Government /Autonomous Body.
- Affidavit in which the bidder undertakes that it is not involved in any litigation.

TERMS AND CONDITIONS:

- As per SPPRA Rule No.46(2)(a) “Single Stage –Two Envelope“ bidding procedure shall adopt as follows.**
 - The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the Technical Proposal & Financial Proposal.
 - After the evaluation & approvals of the technical proposals by the technical committee on the basis of the documents Experience, feature of the Material samples of the described items in the catalogue and instrumentations, the GC, University Hyderabad shall at the time within the bid validity of minimum of Ninety Days publically, open the financial proposals of the technically accepted bids only, on the date and time communicated letter by this university to the technically approved bidders. The Financial proposals of bids found technically non acceptable shall be returned without opening financial proposals to the respective bidders.
 - Tender documents can be obtained against the written request on company letter head along with Proprietor’s CNIC copy or authorized nominee from the office of the **Project Coordinator, Government College University Hyderabad** with a pay order / demand draft as tender fee mentioned above (nonrefundable) in favor of **Project Coordinator, Government College University Hyderabad.**

 - Bids must be offered on the prescribed bidding documents issued by Government College University Hyderabad including an applicable government taxes (Federal/Provincial/Local Bodies).
